But the bid can only be submitted to Officer Commanding, Construction Squadron, National Security Guard, Manesar Distt Gurgaon (Haryana) by uploading the mandatory scanned documents such as Demand Draft of any scheduled bank towards EMD in favour of **PAO HQ NSG New Delhi** and other documents as specified.
