INVITING TENDER NOTICE**

The Officer Commanding, Construction Squadron, National Security Guard, Manesar Distt Gurgaon (Haryana) on behalf of President of India invites **item rate** tenders on two bid system from approved and eligible contractors of CPWD and those of appropriate list of M.E.S., BSNL, Railway, DDA, GDA and State PWD Delhi or Haryana (B & R) in **Civil category** who have satisfactorily executed Three similar nature completed works costing not less than the amount equal to 40% of estimated cost put to tender, or two similar completed works, costing not less than the amount equal to 60% of the estimated cost put to tender or one similar completed work of aggregate cost not less than the amount equal to 80% of the estimated cost **in the last five years** ending the last month previous to the one which the tender is invited :-

1. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
2. Information and Instructions for bidders posted on website shall form part of bid document.
3. The bid document consisting specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from CPP Portal (<http://eprocure.gov.in/epublish/app>) & NSG official website (<http://nsg.gov.in>) free of cost.
4. But the bid can only be submitted to Officer Commanding, Construction Squadron, National Security Guard, Manesar Distt Gurgaon (Haryana) by uploading the mandatory scanned documents such as Demand Draft of any scheduled bank towards EMD in favour of **PAO HQ NSG New Delhi** and other documents as specified.
5. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
6. Contractor can upload documents in the form of JPEG format and PDF format.
7. Contractor must ensure to quote item rate.
8. **The contractor whose bid is accepted will also be required to furnish copy of applicable labour license and BOWC welfare Board within the period specified in schedule "F" if applicable.**
9. **Original Demand Draft for cost of tender shall be deposited in the office of the Construction Squadron, NSG Manesar on or before the opening date upto 11:30 Hrs.**
10. List of Documents other than financial instruments to be scanned and uploaded within the period of bid submission:
 - i) Demand Draft/TDR of any scheduled Bank against EMD.
 - ii) Demand Draft for cost of tender.
 - iii) Enlistment Order of the Contractor.
 - iv) Scanned copy of the VAT registration/Sale Tax registration and **Service Tax registration.**
 - v) **Authorization letter for yonex court mat is mandatory and provided by the original manufacturer or their representative/distributor for India for the particular work.**
 - vi) **Work completion certificate.**
 - vii) An undertaking that **"The physical EMD shall be deposited by me/us with the OC Construction Sqn calling the tender, in case I/We become the lowest tenderer within a week of the opening of the financial bid otherwise Department may reject the tender and also take action to withdraw my/our enlistment."**
