

3 Personnel while on deputation with the NSG would continue to draw the basic pay being drawn by them in their parent department and would be entitled to the following pay and allowances:-

- (a) Basic pay/DA as admissible in the scale of pay of the rank held in the parent organization.
- (b) Other allowances admissible to the Central Govt. employees from time to time
- (c) NSG allowance @ 25% of total emoluments (excluding HRA and CCA).
- (d) Concession of free ration according to Army scale and rent free unfurnished family accommodation or HRA plus CILQ at the rates sanctioned from time to time.
