

**PRESS NOTICE
INVITING TENDER NOTICE**

The Officer Commanding, Construction Squadron, National Security Guard, Manesar Distt Gurgaon (Haryana) on behalf of President of India invites **online percentage rate** tenders on two bid system for the following works from the eligible Contractor CPWD, **specialized agency** and those of appropriate list of department of MES, BSNL, Railways and Haryana State PWD(B&R) who have satisfactorily executed three similar works costing at least **Rs.9 lacs** each or two similar works costing **Rs.13.5 lacs** each or one similar work costing at least **Rs.18 lacs** in the last seven years ending the last month previous to the one which the tenders are invited. The contractor has to submit attested copy of definite proof of the similar "Nature of works satisfactorily completed and the original certificate also to be shown at the time of Submission of application. Attested copy of Anti-Bacterial agent manufacturer having licenses with approved list from Food and Drugs Administration (FDA) and certificate issued in manufacturer name by a Govt. Approved Laboratory for Non Toxicity of Anti Bacterial as per OECD guidelines. Authentic letter to produce any supporting documents.

"Similar nature of works means that the work specified on the Schedule of Quantity" & Cleaning of overhead RCC tank of height & capacity at least 25 Mtrs & 2.75 lacs liters respectively.

1. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
2. Information and Instructions for bidders posted on website shall form part of bid document.
3. The bid document consisting specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from CPP Portal (<http://eprocure.gov.in/epublish/app>) & NSG official website (<http://nsg.gov.in>) free of cost.
4. But the bid can only be submitted to Officer Commanding, Construction Squadron, National Security Guard, Manesar Distt Gurgaon (Haryana) by uploading the mandatory scanned documents such as Demand Draft of any scheduled bank towards EMD in favour **PAO HQ NSG New Delhi** of and other documents as specified.
5. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
6. Contractor can upload documents in the form of JPEG format and PDF format.
7. Contractor must ensure to quote percentage rate.
8. **The contractor whose bid is accepted will also be required to furnish copy of applicable labour license and BOWC welfare Board within the period specified in schedule F.**
9. **"The reimbursement of EPF & ESI contributions paid by the contractor on the part of employer is to be made on submission of documentary proof of payment provided the same is in order. Similarly, the reimbursement of service tax/GST paid by the contractor on behalf of employer is to be made on submission of documentary proof of payment provide same is in order."**
10. **Original Demand Draft for cost of tender shall be deposited in the office of the Construction Squadron, NSG Manesar on or before the opening date upto 11:30 Hrs.**
11. List of Documents other than financial instruments to be scanned and uploaded within the period of bid submission:
 - i) Demand Draft/TDR of any scheduled Bank against EMD.
 - ii) Demand Draft for cost of tender.
 - iii) Enlistment Order of the Contractor.
 - iv) **Scanned copy of the Goods and Service Tax (GST) registration Certificate.**
 - v) Scanned copy of **EPF and ESIC registration.**
 - vi) Work Completion Certificate.
 - vii) An undertaking that **"The physical EMD shall be deposited by me/us with the OC Construction Sqn calling the tender, in case I/We become the lowest tenderer within a week of the opening of the financial bid otherwise Department may reject the tender and also take action to withdraw my/our enlistment."**
