1. **The application for tenders should be accompanied with valid registration documents of contractor in the appropriate class, EPF registration certificate, ESI registration certificate, GST registration Certificate, PAN Card etc duly self attested and with cost of tender.**
2. Earnest Money Deposited through DD of schedule bank drawn in favour of the PAO, HQ NSG Payable at New Delhi shall be deposited with the tender documents in separate envelope marked as "Earnest Money". The applications of those who do not deposit EMD (**validity more than 45 days**) are liable to be rejected.
3. Both sealed envelope (EMD and Tender documents) marked as "Earnest money" and "Tender" shall be submitted together in another sealed envelope subscribed with name of work and due date of opening.
4. Contractor must ensure to quote percentage rate.
5. **The contractor whose bid is accepted will also be required to furnish copy of applicable labour licenses, registration with BOWC welfare Board and Programme Chart (Time and progress) within the period specified in schedule F.**
6. **"The reimbursement of EPF & ESI contributions paid by the contractor on the part of employer is to be made on submission of documentary proof of payment provided the same is in order. Similarly, the reimbursement of service tax etc paid by the contractor on behalf of employer is to be made on submission of documentary proof of payment provide same is in order."**
7. Intending bidders/registered contactors who are exempted from depositing tender sale cost & Earnest money deposit (EMD) are requested to submit their undertaking during submission of tender regarding exemption of tender sale cost & Earnest money deposit (EMD) along with relevant circular/order issued by Government.
