**INFORMATION AND INSTRUCTIONS FOR BIDDERS FOR e-TENDERING FORMING PART OF BID DOCUMENT AND TO BE POSTED ON WEBSITE.**

The Squadron Commander (Engg), National Security Guard, Mehram Nagar (Opposite domestic Airport), Palam, New Delhi on behalf of President of India invites item rate tenders from specialized agency who completed "Three similar works each of value not less than 40% of estimated cost or two similar work each of value not less than 60% of estimated cost or one similar work of value not less than 80% of estimated cost put to tender in last 7 years ending last day of the month previous to the one in which the tenders are invited" for the work :

- The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he consider himself eligible and he is in possession of all the documents required.
- Information and Instructions for bidders posted on website shall form part of bid document.
- The bid document consisting specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from CPP Portal (<http://eprocure.gov.in/epublish/app>) & NSG official website (<http://nsg.gov.in>) free of cost.
- But the bid can only be submitted to SC(Engg), National Security Guard, Palam, New Delhi-110037 by uploading the mandatory scanned documents such as Demand Draft or Pay order or Banker's Cheque or Deposit at call receipts or Fixed Deposit Receipts and Bank Guarantee of any scheduled bank towards EMD in favour PAO,NSG (MHA), New Delhi of and other documents as specified.
- On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- Contractor can upload documents in the form of JPG format and PDF format.
- Contractor must ensure to quote rate of each item. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
- The contractor whose bid is accepted will also be required to furnish either copy of applicable Licenses /registrations or Proof of applying for obtaining labour licenses, registration with EPFO, ESIC and BOWC Welfare Board and Programme Chart (Time and Progress) within the period specified in schedule F.
- "The reimbursement of EPF & ESI contributions paid by the contractor on the part of employer is to be made on submission of documentary proof of payment provided the same is in order. Similarly, the reimbursement of service tax paid by the contractor on behalf of employer is to be made on submission of documentary proof of payment provided same is in order."
- List of Documents other than financial instruments to be scanned and uploaded within the period of bid submission:
  - Demand Draft/ FDR/ Bank Guarantee of any scheduled Bank against EMD.
  - Original Demand Draft for cost of tender shall be deposited in the office of the SC(Engg), HQ NSG New Delhi on or before the opening date upto 11:00 Hrs.
  - Enlistment Order of the Contractor.
  - Certificate of Registration for GST/PAN etc.
  - An undertaking that "The physical EMD shall be deposited by me/us with the Sqn Cdr (Engg) HQ NSG Palam calling the tender, in case I/We become the lowest tenderer within a week of the opening of the financial bid otherwise Department may reject the tender and also take action to withdraw my/our enlistment."
  - Intending bidders/registered contractors who are exempted from depositing Tender sale cost & Earnest money deposit(EMD) are requested to upload their undertaking regarding exemption of tender sale cost and Earnest money deposit(EMD) along with relevant circular / order issued by Government.
