As per the Recruitment Rules notified, these posts are to be filled by transfer on deputation from amongst the personnel holding analogous posts on regular basis and having two years working experience in the relevant field. Further if the above mentioned ranks are not available in your organization then the equivalent rank personnel can be nominated for the said posts.

3. Personnel while on deputation with the NSG would continue to draw the basic pay being drawn by them in their parent departments/organizations and would be entitled to the following pay and allowances as under:-

- (a) Basic pay / DA as admissible in the scale of pay of the rank held in the parent organization.
- (b) Special Security Allowance @ 40% of basic pay.
- (c) Other allowances admissible to the Central Govt employees from time to time.
- (d) Concession of free ration according to Army scale/Ration Money Allowance.
- (e) Rent free unfurnished family accommodation or HRA.
