- (c) Nature of apptt. - Full time basis;
- (d) Leave entitlement - As per DoP&T's OM No. 12016/3/84-Estt (L) dated 12.04.1985 amended as from time to time;
- (e) Medical Examination - The selected candidates will be subject to medical screening test as prescribed for regular apptt;
- (f) The contractual appointment will be subject to verification of character and antecedents of the candidates;
- (g) The appointee shall not be entitled to any benefits like Pension, Gratuity, Medical Allowance, Seniority/Promotion, etc. or any other benefits as available to the regular Government Servants appointed on regular basis;
- (h) The appointee shall be on whole time appointment of the institution and shall not accept any other appointment, paid or otherwise during the period of contract;
- (j) The contractual appointment carries with it the liability to serve in any part of the country;
- (k) The appointee will furnish a declaration regarding his/her marital status;
- (l) On contractual appointment, the appointee will be required to take an oath and allegiance to the Constitution of India and make a solemn affirmation to the effect in the prescribed proforma;
- (m) The appointment can be terminated at any time by giving one month's notice (on either side) without assigning any reason by paying/refunding one month's salary;
- (n) No TA/DA is admissible for the interview and subsequently for joining the post;
- (o) All the relevant rules and orders issued from time to time shall invariably be applicable to contractual appointees;
- (p) The appointment is subject to the physical fitness from the competent medical board for which he will be sent to the designated Medical Authority every year;

- (q) The appointee shall not have any claim or right to regular appointment to any post under CAPFs;
