SUBJECT : FILLING UP VACANCY OF SQUADRON COMMANDER/EE (CIVIL), TEAM COMMANDER/AE (CIVIL & ELECT) AND TEAM COMMANDER (ARCH) IN NSG ON DEPUTATION

1. It is proposed to fill up the following vacancies of Squadron Commander/EE (Civil) and Team Commander/AE (Civil & Electrical) in NSG on deputation basis: -

(a)	Sqn Comdr/ EE (Civil) (Level 11 of Pay Matrix)	01	- Holding analogous posts on regular basis (holding post of EE (Civil) and drawing pay in level-11 or above); - Degree in Civil Engineering; - Medical category SHAPE-1 (should be medically fit); - Age not exceeding 54 years.
(b)	TC/AE (Civil) (Level 10 of Pay Matrix)	04	- Holding analogous posts on regular basis (holding post of AE (Civil) and drawing pay in level-10 or above); - Degree in Civil Engineering; - Medical category SHAPE-1 (should be medically fit); - Age not exceeding 54 years.

(c)	TC/AE (Elect) (Level 10 of Pay Matrix)	01	- Holding analogous posts on regular basis (holding post of AE (Elect) and drawing pay in level-10 or above); - Degree in Electrical Engineering; - Medical category SHAPE-1 (should be medically fit); - Age not exceeding 54 years.
(d)	TC (Arch) (Level 10 of Pay Matrix)	01	- Holding analogous posts on regular basis (holding post of Architect and drawing pay in level-10 or above); - Degree in Architecture; - Medical category SHAPE-1 (should be medically fit); - Age not exceeding 54 years.

2. The normal tenure of deputation shall be five years. The entitlement of pay and allowances/other benefits in the deputation posts are as under: -

- (a) Basic pay and DA as admissible in the Pay Matrix of the post held in the parent organisation.
- (b) NSG allowance @ 40% of basic pay.
- (c) Other allowances as admissible to the Central Govt. Employees from time to time.
- (d) Govt. accommodation or HRA in lieu thereof as admissible.

3. It is requested that nominations of willing and eligible officers for filling up above posts may please be forwarded to this HQ as per enclosed proforma along with APAR grading for the last five years (copy of APAR not required), DE/vigilance clearance and medical category certificates, latest by **15th Sept, 2021**, to assess their suitability for deputation to NSG.
